granting an authorisation under Regulation (EC) No 1907/2006 of the European Parliament and of the Council to Brenntag Chemicals Distribution (Ireland) Ltd and others for a use of chromium trioxide, sodium dichromate, potassium dichromate and sodium chromate

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EC) No 1907/2006 of the European Parliament and of the Council of 18 December 2006 concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH), establishing a European Chemicals Agency, amending Directive 1999/45/EC and repealing Council Regulation (EEC) No 793/93 and Commission Regulation (EC) No 1488/94 as well as Council Directive 76/769/EEC and Commission Directives 91/155/EEC, 93/67/EEC, 93/105/EC and 2000/21/EC¹, and in particular Article 64(8) thereof,

Whereas:

- (1) Chromium trioxide, sodium dichromate, potassium dichromate and sodium chromate are listed in Annex XIV to Regulation (EC) No 1907/2006, and uses of those substances are subject to the authorisation requirement in Article 56(1), point (a), of that Regulation.
- (2) On 22 October 2019, by Commission Implementing Decision C(2019) 7447², an authorisation was granted to Aviall Services Inc. and Wesco Aircraft EMEA Limited for the use of sodium chromate in formulation of mixtures for sealing after anodising, chemical conversion coating, pickling and etching applications by the aerospace sector. Aviall Services Inc. and Wesco Aircraft EMEA Limited were assigned, for that use, authorisation numbers REACH/19/32/0 and REACH/19/32/1 respectively. The expiry of the review period referred to in Article 60(9), point (e), of Regulation (EC) No 1907/2006 for that authorised use of sodium chromate was set at 21 September 2024.
- (3) On 8 April 2020, by Commission Implementing Decision C(2020) 2073³, an authorisation was granted to Brenntag UK Ltd for certain uses of potassium dichromate including in formulation of mixtures intended exclusively for surface

treatment of metals (such as aluminium, steel, zinc, magnesium, titanium, alloys), composites and sealings of anodic films for the aerospace sector in the surface treatment processes in which any key functionalities listed in the Annex to that Decision is required. Brenntag UK Ltd was assigned, for that use, authorisation number REACH/20/3/0. The expiry of the review period referred to in Article 60(9), point (e), of Regulation (EC) No 1907/2006 for that authorised use of potassium dichromate was set at 21 September 2024.

- (4) On 14 April 2020, by Commission Implementing Decision C(2020) 2084⁴, an authorisation was granted to Brenntag UK Ltd and AD International BV for the use of sodium dichromate in formulation of mixtures intended exclusively for uses REACH/20/5/3, REACH/20/5/5, REACH/20/5/6 and REACH/20/5/8. Brenntag UK Ltd and AD International BV were assigned, for that use, authorisation numbers REACH/20/5/0 and REACH/20/5/2 respectively. The expiry of the review period referred to in Article 60(9), point (e), of Regulation (EC) No 1907/2006 for that authorised use of sodium dichromate was set at 21 September 2024.
- (5) On 18 December 2020, by Commission Implementing Decision C(2020) 8797⁵, an authorisation was granted to Chemservice GmbH, Boeing Distribution Inc. and Cromital S.P.A. for certain uses of chromium trioxide, including in formulation of mixtures exclusively for uses REACH/20/18/7 to REACH/20/18/34 ('Chemservice use 1'). Chemservice GmbH, Boeing Distribution Inc. and Cromital S.P.A. were assigned, for that use, authorisation numbers REACH/20/18/0, REACH/20/18/2 and REACH/20/18/4 respectively. The expiry of the review period referred to in Article 60(9), point (e), of Regulation (EC) No 1907/2006 for that authorised use of chromium trioxide was set at 21 September 2024.
- (6) On 20 August 2019, the European Chemicals Agency ('Agency') received a notification that Boeing Distribution Inc. had succeeded in the rights and obligations of Aviall Services Inc. In its assessment, the Agency concluded that the notified change had no implications for the relevant Committee for Risk Assessment ('RAC') and Committee for Socio-economic Analysis ('SEAC') opinions referred to in Implementing Decision C(2019) 7447. The Commission accepts that conclusion.
- (7) On 20 November 2020, the Agency received a notification that Cromital S.P.A. in its legal capacity as Only Representative of Türkiye Şişe ve Cam Fabrikaları A.S. had succeeded in the rights and obligations of Cromital S.P.A. in its legal capacity as Only Representative of Soda Sanayii A.S. In its assessment, the Agency concluded that the notified change had no implications for the relevant RAC and SEAC opinions referred to in Implementing Decision C(2020) 8797. The Commission accepts that conclusion.
- (8) On 30 November 2020, the Agency received a notification that Haas Group International sp. z.o.o. had succeeded in the rights and obligations of Wesco Aircraft EMEA Limited. In its assessment, the Agency concluded that the notified change had no implications for the relevant RAC and SEAC opinions referred to in Implementing Decisions C(2019) 7447. The Commission accepts that conclusion.

- (9) On 19 December 2020, the Agency received a notification that Brenntag Chemicals Distribution (Ireland) Ltd had succeeded in the rights and obligations of Brenntag UK Ltd. In its assessment, the Agency concluded that the notified change had no implications for the relevant RAC and SEAC opinions referred to in Implementing Decisions C(2020) 2073 and C(2020) 2084. The Commission accepts that conclusion.
- (10) On 8 September 2023, the Agency received a notification that Boeing Distribution Deutschland GmbH had succeeded in the rights and obligations of Boeing Distribution Inc. In its assessment, the Agency concluded that the notified change had no implications for the relevant RAC and SEAC opinions referred to in Implementing Decision C(2019) 8797. The Commission accepts that conclusion.
- (11) On 15 February 2023, Brenntag Chemicals Distribution (Ireland) Ltd, AD International BV, Boeing Distribution Deutschland GmbH, Cromital S.P.A., Haas Group International sp. z.o.o. and Chemservice GmbH ('the applicants') submitted a review report in accordance with Article 61(1) of Regulation (EC) No 1907/2006 for authorisation for a use of chromium trioxide, sodium dichromate, potassium dichromate and sodium chromate. The use for which authorisation was sought is formulation of mixtures with soluble Cr(VI) compounds for use in aerospace and defence industry and its supply chains for surface treatments.
- (12) The judgment of the Court of 20 April 2023 in Case C-144/21, *European Parliament v. Commission*⁶, partially annulled Implementing Decision C(2020) 8797. The annulment covered also Chemservice use 1, only insofar as referring to the uses with authorisation bearing numbers REACH/20/18/7 to REACH/20/18/27. Therefore, for the purpose of this Decision, the review report submitted should be considered an application for authorisation as regards the use of chromium trioxide.
- (13) The Agency sent the opinions⁷ on the review report adopted by RAC and SEAC to the Commission pursuant to Article 64(5), third subparagraph, of Regulation (EC) No 1907/2006. On 28 September 2024, the Commission received the opinions.
- (14) In its opinion, RAC concluded that it is not possible to determine a derived no-effect level for the carcinogenic and mutagenic properties of chromium trioxide, sodium dichromate, potassium dichromate and sodium chromate in accordance with Section 1.4 of Annex I to Regulation (EC) No 1907/2006 and that therefore chromium trioxide, sodium dichromate, potassium dichromate and sodium chromate are substances for which it is not possible to determine a threshold for the purposes of Article 60(3), point (a), of that Regulation. As a result, Article 60(2) of Regulation (EC) No 1907/2006 does not apply to chromium trioxide, sodium dichromate, potassium dichromate and sodium chromate and an authorisation may therefore only be granted with respect to those substances under paragraph 4 of that Article.
- (15) In its opinion, RAC concluded that the risk management measures and operational conditions described in the review report and in the application are not appropriate and effective in limiting the health risk to workers, posed by the use of chromium trioxide, sodium dichromate, potassium dichromate and sodium chromate described in the review report. However, RAC concluded that they are appropriate and effective in limiting the health risk to the general population posed by that use. In particular, as

regards occupational exposure, RAC highlighted concerns about the manual nature of certain tasks, the absence of local exhaust ventilation for certain processes and the lack or inappropriate use of respiratory protective equipment. Therefore, and in order to contribute to the improvement of the risk management measures with the aim of minimising occupational exposure to hexavalent chromium (Cr(VI)), the toxic component of chromium trioxide, sodium dichromate, potassium dichromate and sodium chromate, RAC recommended imposing additional conditions for authorisation.

- (16) Moreover, RAC considered it important that the applicants address minor shortcomings in their exposure assessment by continuing their monitoring programmes and increasing their frequencies, if applicable, by carrying out specific measurements of the workers' exposure, per worker contributing scenario, and of environmental releases, as specified in the monitoring arrangements recommended by RAC.
- (17) Having evaluated RAC's assessment, the Commission agrees with its conclusion and recommendations. Nevertheless, the Commission notes that the estimated excess cancer risk values for workers are higher than as regards other comparable applications for authorisation for the use of Cr(VI) substances. Although the Commission acknowledges that those values are conservative estimates of the most likely excess risk values taken for the purpose of carrying out a risk-benefit analysis, it considers it appropriate to set out the measures concerning occupational exposure, recommended by RAC as monitoring arrangements, as conditions for authorisation.
- (18) In its opinion, SEAC concluded that the societal costs of not granting an authorisation are higher than the monetised risk to human health arising from the use of chromium trioxide, sodium dichromate, potassium dichromate and sodium chromate described in the review report and in the application. The Commission, having evaluated SEAC's assessment, concurs with that conclusion and considers that the authorisation holders have demonstrated that the benefits of the continued use outweigh the risk to human health arising from that use.
- (19) In its opinion, SEAC concluded that there is no function per se provided by the substances in the use applied for (formulation of mixtures). Such mixtures are intended exclusively to serve subsequent uses as authorised under Regulation (EC) No 1907/2006. Therefore, SEAC did not consider as relevant the analysis of alternatives. The Commission, having evaluated SEAC's assessment, agrees with that conclusion and considers fulfilled the condition that there are no suitable alternatives.
- (20) However, the Commission considers it appropriate to adjust the use description as to reflect that those mixtures are intended exclusively to serve subsequent uses as authorised under Regulation (EC) No 1907/2006 in aerospace and defence industry and its supply chains for surface treatments.
- (21) Therefore, having regard to the conditions laid down in Article 60(4) of Regulation (EC) No 1907/2006, it is appropriate to authorise the use of chromium trioxide, sodium dichromate, potassium dichromate and sodium chromate described in this Decision, provided that the risk management measures described in the chemical safety report are applied and that the operational conditions described therein, as well as the conditions set out in this Decision, are fulfilled.
- (22) The Commission has based its assessment on all relevant scientific evidence available, as assessed by RAC and SEAC, and, after having carried out a detailed examination,

has concluded on the basis of a sufficient amount of material and reliable information. Nevertheless, additional scientific evidence would allow the Commission to perform its assessment on a more robust or broad evidentiary basis in the future. Hence, it is appropriate to require that the authorisation holders generate and include additional information about exposure and emissions in the review report.

- (23) In its opinion, SEAC recommended that the review period referred to in Article 60(9), point (e), of Regulation (EC) No 1907/2006 be set at 12 years. The Commission agrees with that recommendation, taking into account the relevant elements from RAC's and SEAC's assessments, in particular RAC's conclusion that the risk management measures are appropriate and effective in limiting the risk to human health for the general population, as well as the recommended additional conditions for authorisation to limit the risk, based on RAC's conclusions that the risk management measures and operational conditions are not appropriate and effective in limiting the risk for workers. The Commission also takes into account SEAC's conclusion on both the socio-economic benefits, including the contribution to the Union strategic autonomy, and the risk associated with the continued use of the substances.
- (24) The language used to describe the risk management measures and operational conditions in the review report may be different from the official language of the Member State where the use takes place. Therefore, in order to facilitate supervision and enforcement of compliance with the authorisation, it is appropriate to require the authorisation holders to submit, upon request, a brief summary of those risk management measures and operational conditions to the competent authority of that Member State in an official language of that Member State.
- (25) This Decision does not affect the obligation of the authorisation holders to ensure that the use of a substance does not adversely affect human health or the environment, having regard to the principle set out in Article 1(3) of Regulation (EC) No 1907/2006. Furthermore, this Decision does not affect the obligation of the authorisation holders under Article 60(10) of that Regulation to ensure that the exposure is reduced to as low a level as is technically and practically possible or the obligation of the employer under Article 4(1) and Article 5 of Directive 2004/37/EC of the European Parliament and of the Council⁸ to reduce the use of carcinogens, mutagens or reprotoxic substances at the place of work, in particular by replacing those substances, in so far as is technically possible, and to prevent workers' exposure to a risk to their health or safety. This Decision does not affect the application of Union law in the area of health and safety at work, in particular Council Directives 89/391/EEC⁹, 92/85/EEC¹⁰, 94/33/EC¹¹, 98/24/EC¹² and Directive 2004/37/EC, or any

national binding occupational limit values which may be stricter than the applicable limit values under Union law.

- (26) This Decision does not affect any obligation to comply with emission limit values or other requirements set in accordance with Directive 2008/50/EC¹³ or Directive 2010/75/EU¹⁴ of the European Parliament and of the Council, nor any obligation to comply with emission limit values set to achieve compliance with the environmental quality standards established by Member States in accordance with Directive 2000/60/EC of the European Parliament and of the Council¹⁵ or the environmental quality standards established in Directive 2008/105/EC of the European Parliament and of the Council¹⁶. Compliance with the provisions of this Decision does not necessarily imply compliance with any emission limit values or environmental quality standards under any other provisions of Union law, which may include further or more onerous requirements.
- (27) The measures provided for in this Decision are in accordance with the opinion of the Committee established by Article 133 of Regulation (EC) No 1907/2006,

HAS ADOPTED THIS DECISION:

Article 1

An authorisation is hereby granted in accordance with Article 60(4) of Regulation (EC) No 1907/2006 to the following persons for the following uses of chromium trioxide (EC No 215-607-8; CAS No 1333-82-0), sodium dichromate (EC: 234-190-3; CAS: 10588-01-9, 7789-12-0), potassium dichromate (EC: 231-906-6; CAS: 7778-50-9) and sodium chromate (EC: 231-889-5; CAS: 7775-11-3):

The authorisation is granted subject to the risk management measures and operational conditions described in the chemical safety report¹⁷, and to the conditions set out in Article 2.

Article 2

1. The authorisation is subject to the conditions set out in paragraphs 2 to 9.
2. Without delay, and at the latest by 20 January 2026, the authorisation holders and their downstream users shall ensure that manual handling of solid and liquid hexavalent chromium (Cr(VI)) substances for measuring, weighing, solution preparation and mixing of solids is performed in dedicated rooms under local exhaust ventilation ('LEV') with high containment.
3. The authorisation holders and their downstream users shall:
 - (a) until adequate technologies or improved operational conditions and risk management measures, which follow the hierarchy of control principles set out in Article 5 of Directive 2004/37/EC, are implemented and exposure data pursuant to the measurements referred to in paragraph 4 or 6 allow for a conclusion that exposure to Cr(VI) is at a level as low as technically and practically possible, ensure that workers performing manual sampling of the

vessels, cleaning, repair and maintenance, use respiratory protective equipment ('RPE'), taking into account the duration of the tasks and the comfort of the workers during its use;

- (b) ensure that the relevant workers:
 - i. are provided with adequate RPE, which has been subjected to a fit test prior to its first use;
 - ii. always perform a fit check of the seal of their RPE before starting a relevant task; and
 - iii. are adequately supported to undergo the fit tests referred to in point (i) and trained to undertake the fit checks referred to in point (ii).

4. The authorisation holders and their downstream users shall conduct control measurements to validate the appropriateness and effectiveness of the additional risk management measures and operational conditions implemented in accordance with paragraph 2. If necessary, additional risk management measures or operational conditions shall be implemented to further reduce exposure to Cr(VI) to a level as low as technically and practically possible.

5. By 20 January 2026 and afterwards each time when new relevant information becomes available, the authorisation holders and their downstream users shall carry out feasibility study on the following measures:

- (a) the implementation of a closed or automatic system to perform the dissolution of solid Cr(VI) substances and any subsequent (re-)filling of vessels with liquid solutions;
- (b) the installation of a closed or automatic system to perform vessel sampling tasks, where exposure to Cr(VI) is expected;
- (c) the installation of a system that continuously controls the LEV and automatically triggers an alarm in case the LEV is not functioning properly and the implementation of appropriate and effective measures to reduce the exposure of workers in case the LEV is not functioning properly.

The authorisation holders and their downstream users shall act in accordance with the outcome of those studies.

6. The authorisation holders and their downstream users shall carry out a monitoring programme measuring occupational exposure to Cr(VI) at all sites. The programme shall include measurements which shall:

- (a) take place at least annually, or more frequently if a significant increase of chromium trioxide, sodium dichromate, potassium dichromate or sodium chromate consumption takes place on site, and shall be sufficiently frequent to capture any potential increase in exposure of workers to Cr(VI);
- (b) be based on relevant standard methodologies or protocols;
- (c) ensure a sufficiently low limit of quantification;
- (d) comprise personal or static inhalation exposure sampling;
- (e) be representative of all the tasks with possible exposure to Cr(VI), including maintenance tasks, of the operational conditions and risk management measures for each of those tasks, and of the total number of workers that are potentially exposed;

- (f) be recorded so as to include contextual information about the tasks performed during exposure sampling.
- 7. The authorisation holders and their downstream users that already conduct a biomonitoring programme at their site shall continue with the programme and shall ensure that it covers a representative number of the workers potentially exposed to Cr(VI).
- 8. The authorisation holders and their downstream users shall use the information gathered by way of the measurements referred to in paragraphs 6 and 7 to review, at least annually, the appropriateness and effectiveness of the risk management measures and operational conditions in place. While doing so, the authorisation holders and their downstream users shall also review and, if needed, update their assessment of the combined exposure for the different groups of workers. If needed, based on the outcome of that review, the authorisation holders and their downstream users shall introduce measures to further reduce to a level as low as technically and practically possible occupational exposure to Cr(VI). Such measures shall follow the hierarchy of control principles set out in Article 5 of Directive 2004/37/EC.
- 9. The authorisation holders and their downstream users shall document and maintain the information from the monitoring programmes referred to in paragraph 6 and 7 and from the control measurements referred to in paragraph 4, including the contextual information associated with each set of measurements, as well as the outcome and conclusions of the reviews and study and any measure taken in accordance with paragraphs 2, 4, 5 and 8, and shall make that information available, including, where relevant, pseudonymised or aggregated biomonitoring results, upon request, to the competent authority of the Member State where the authorised use takes place.

Article 3

The review period shall expire on 15 February 2035.

The authorisation shall cease to be valid on 15 February 2035 in relation to any authorisation holder who has not submitted the review report in accordance with Article 61(1) of Regulation (EC) No 1907/2006 by 15 August 2033.

Article 4

- 1. The monitoring arrangements set out in paragraphs 2 to 4 shall apply.
- 2. The authorisation holders and their downstream users shall carry out a monitoring programme measuring the environmental releases of Cr(VI) to the air and wastewater at all sites. The programme shall include measurements which shall:
 - (a) take place at least annually, or more frequently if a significant increase of chromium trioxide, sodium dichromate, potassium dichromate or sodium chromate consumption takes place on site, and shall be sufficiently frequent to capture any potential increase in emission of Cr(VI);
 - (b) be based on relevant standard methodologies or protocols;
 - (c) ensure a sufficiently low limit of quantification;
 - (d) be representative of the operational conditions and risk management measures used at the sites where the authorised use takes place;

- (e) be recorded so as to include contextual information associated with each set of measurements.
3. The authorisation holders and their downstream users shall use the information gathered by way of the measurements referred to in paragraph 2 to review, at least annually, the appropriateness and effectiveness of the risk management measures and operational conditions in place. While doing so, the authorisation holders and their downstream users shall also review and, if needed, update their assessment of the exposure of the general population via the environment. If needed, based on the outcome of that review, the authorisation holders and their downstream users shall introduce measures to further reduce to a level as low as technically and practically possible Cr(VI) emissions to the environment.
4. The authorisation holders and their downstream users shall document and maintain the information from the monitoring programme referred to in paragraph 2, including the contextual information associated with each set of measurements, as well as the outcome and conclusions of the reviews and any measure taken in accordance with paragraph 3, and shall make that information available, upon request, to the competent authority of the Member State where the authorised use takes place.

Article 5

If a review report is submitted, it shall include the information referred to in Article 2(9) and Article 4(4).

Article 6

Upon request, the authorisation holders and their downstream users shall submit a brief summary of the applicable risk management measures and operational conditions described in the chemical safety report to the competent authority of the Member State where the authorised use takes place. The brief summary shall be drafted in an official language of that Member State.
